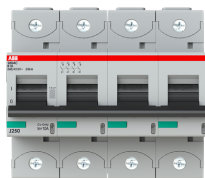

The S804C-B10 is a 4-pole High Performance Circuit breaker with B-characteristic, with cage terminal and a rated current of 10 A. It is a current limiting device with a maximum breaking capacity of 25kA at 240/415V. It can be used for voltages up to 254/440V and in DC as well. It has two different tripping mechanisms, the thermal tripping mechanism for overload protection and the electromechanic tripping mechanism for short circuit protection. The S804C-B10 complies with IEC/EN 60898-1 and IEC/EN 60947-2 and allows the use for residential, commercial and industrial applications.
