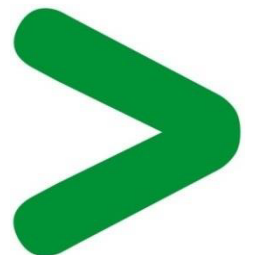
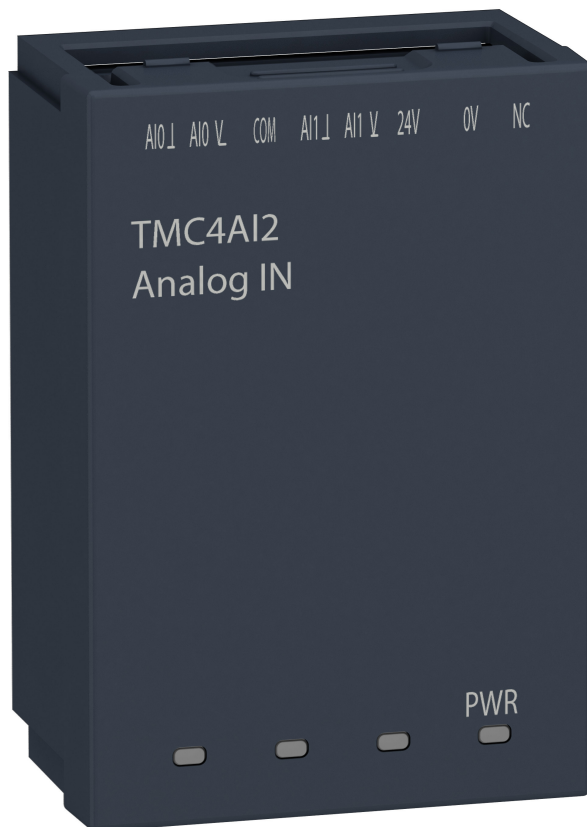

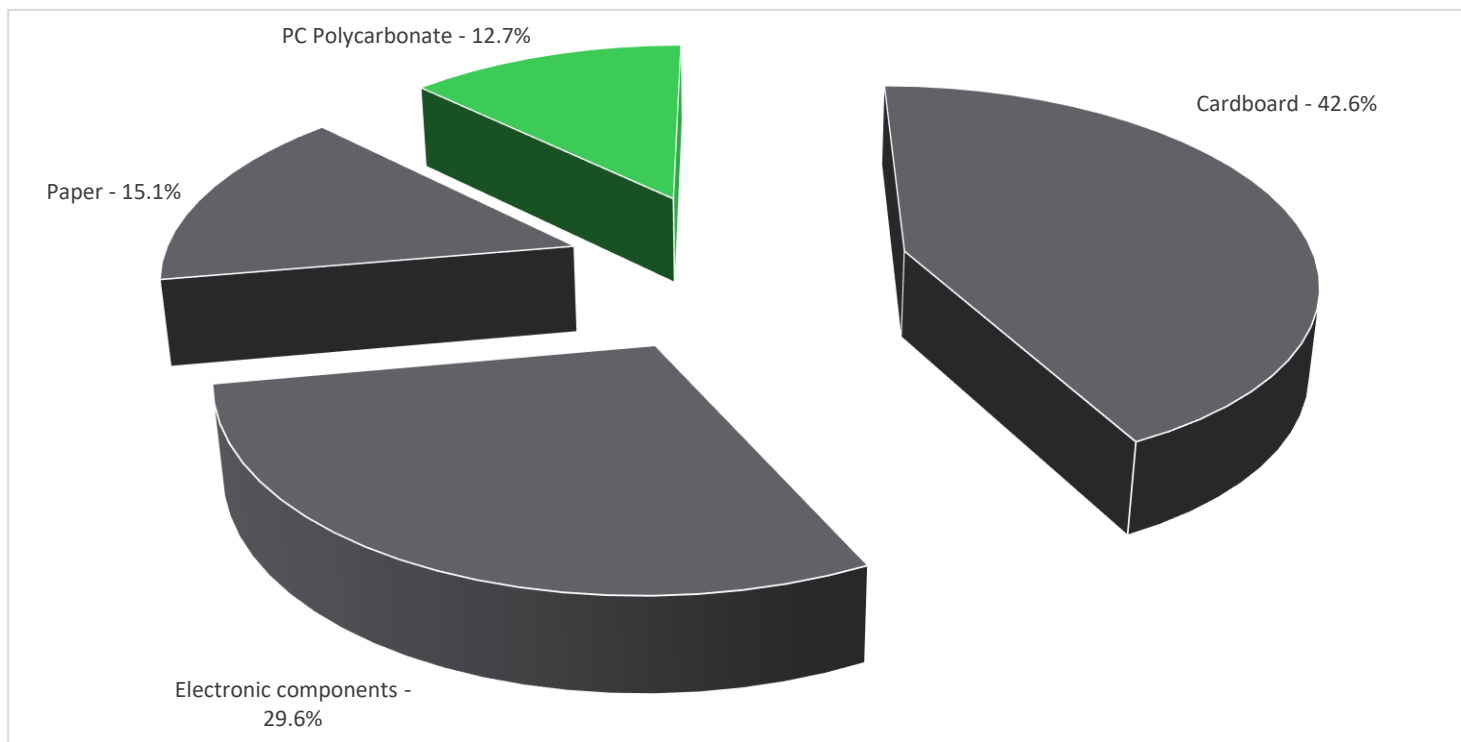
## General information

<b>Description of the range</b>	The main purpose of the TMC Cartridge is to provide more IO capacity of TM221 & TM241 which includes analog input and output, temperature input.  The environmental impacts of this referenced product are representative of the impacts of the other products of the range which are developed with a similar technology.
<b>Functional unit</b>	to extend I/O communication capacities ( 2 analog inputs/outputs, 2 temperature inputs) of the Modicon M221 and M241 Logic Controllers 100% of the time for 10 years

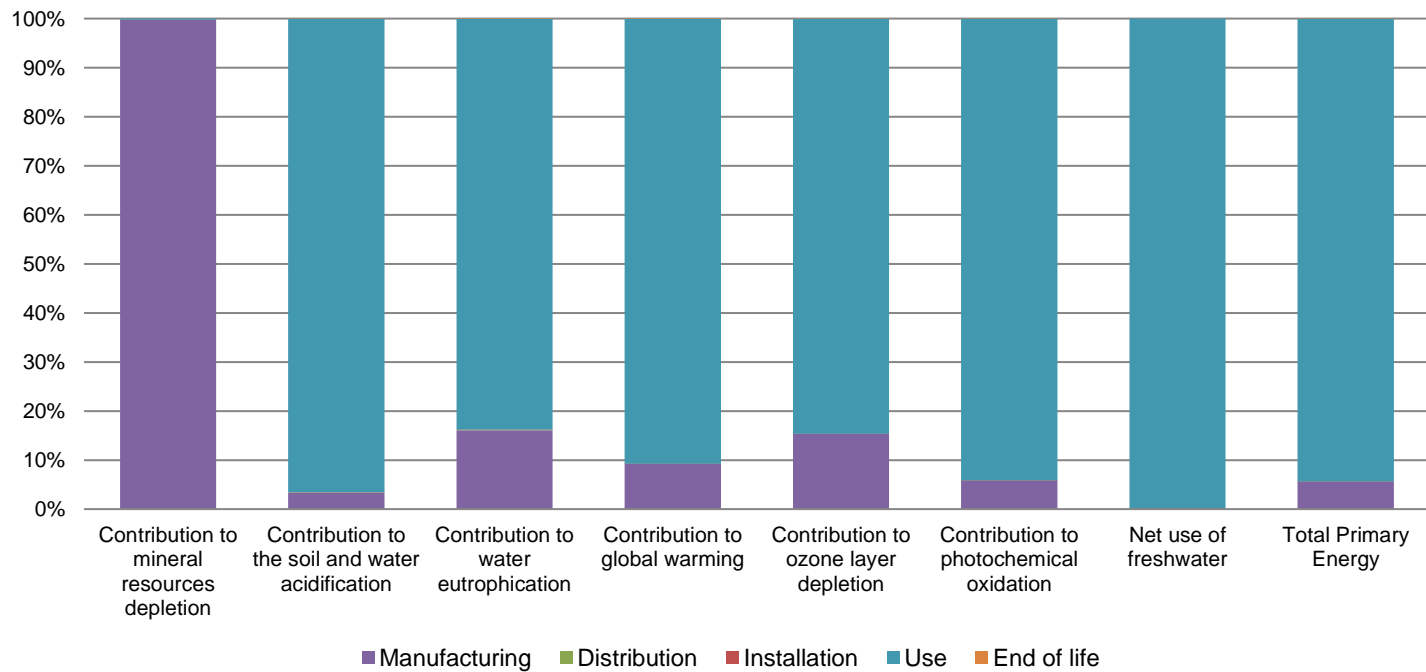
