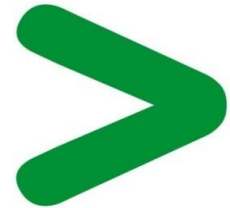

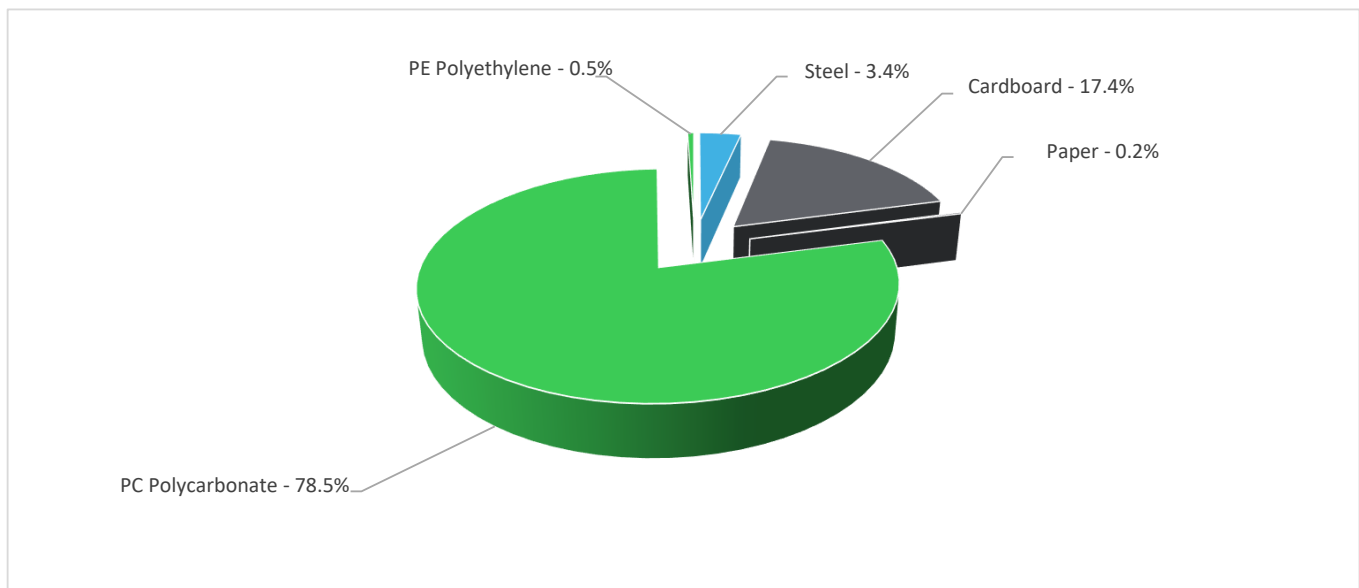
## General information

<b>Description of the product</b>	The Surface Mounted Box to extend mounting possibilities for anti-vandalism range and could be combined with anti-vandalism frames and covers.
<b>Functional unit</b>	This product Protect persons during 20 years against direct contact with live parts and allow grouping monitoring, control and protection devices in a single enclosure or a cabinet having the following dimensions 99mm x 99mm x 48mm, while protecting against mechanical impacts (IK 08) and the penetration of solid objects and liquids (IP 20) in accordance with Environmental standards IEC 60529 and EN IEC 63000:2018, EN 60670-1: 2005 + A1:2013 and EN 60670-22:2006.

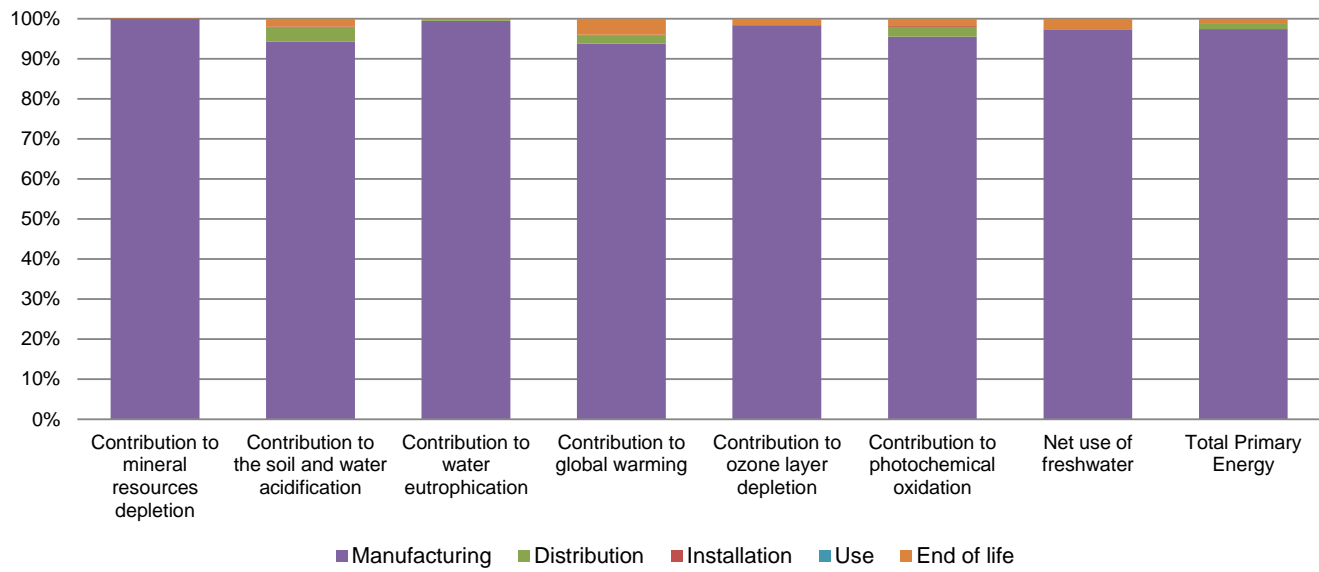
